It is submit that Apprenticeship training is perceived as a critical scheme to develop Industry with ready manpower by utilizing the existing training facilities in Establishments. While receiving the performance of Apprenticeship Training in Telangana it has been observed that only 4500 Apprentices are undergoing Apprenticeship Training.

Further it is to submit that as above reference cited, on Apprenticeship portal,129043 Manpower strength is available in all Establishments registered on Apprenticeship portal if all Establishments under jurisdiction of Telangana engage prescribed maximum 10% of total manpower strength as Apprentices, this would significantly increase the number of Apprentices trained to 12904.

In this regard, the addressed all the CPSUS/CGs instructed to participate Apprenticeship Mela on 04<sup>th</sup> October, 2021 for engagement of Apprentices under the Apprentices Act, 1961. This will bring an excellent opportunity for the engagement of Apprentices in the Establishments to facilitate desires level of productivity vis-à-vis giving an opportunity to Apprentices for an exposure to actual job situation in the industry.

In this regard the activity must be carried to engage more Apprentices.
