Subject: Selection of 49 ICs under Phase-3 of STRIVE Programme- Reg.

In accordance with the CCEA note on STRIVE dated 10th October 2017, around 100 Industrial Clusters (ICs) were proposed to be selected under Result Area-4 of STRIVE with an average allocation of Rs. 1 crore per IC. So far 33 ICs have been selected under phase 1 and 2.

2. The National Steering Committee (NSC) of STRIVE project, during its 6th meeting held on 12th December 2022, approved selection of 49 ICs from the existing pool of ICs recommended by State Steering Committee and evaluated by National Cluster Evaluation Committee (NCEC) during previous selection phases. The list of selected ICs and their state is given in **Annexure I**. Additionally, the committee approved that the implementation of apprenticeship training in these newly selected Industry Clusters will be in accordance with the NAPS guidelines, STRIVE Operational Manual and the recent Office Memorandums issued on simplification of processes in apprenticeship training.

3. The selection of all the 49 ICs is subject to the fulfillment of the following criteria as per STRIVE mandate:

- a) The selected IC must establish an Apprenticeship Implementation Cell (AIC) or equivalent in accordance with the requirements of the STRIVE programme.
- b) Selected IC to open a dedicated bank account with Bank of India for all fund flows related to the STRIVE programme.
- c) A tripartite Performance Based Grant Agreement (PBGA) to be signed between MSDE, respective State Government and AIC for the IC.

In view of the above, the selected states are requested to take necessary action for the onboarding of selected ICs under the RA 4 of STRIVE programme.
